

TUH terms and conditions

Rate rise 2021

- The promoter is Queensland Teachers' Union Health Fund Limited ABN 38 085 150 376 of 438 St Pauls Terrace, Fortitude Valley QLD 4006 ('TUH').
 - The promotion commences at 12.00am on Monday 22 February 2021 and closes at 11.59pm on Thursday 1 April 2021.
 - Permit details:

 - ACT permit number TP 21/00126.1

 - The draw will be conducted on Monday 12 April 2021 at 10am at the registered premises of TUH, 438 St Pauls Terrace, Fortitude Valley, Brisbane.
 - The first entry, drawn randomly using randomdraws.com.au, that meets these terms and conditions will receive the prize.
 - It is a condition of entry that prize winner agrees that their name may be published on the TUH website and social media channels and/or used in other forms of marketing material by TUH, without TUH seeking further approval or the payment of any consideration.
 - Should TUH not be able to contact a prize winner by Monday 19 April 2021 using the contact details it has on record, a further draw will occur until a winner has been determined. The second draw will be conducted on Tuesday 20 April 2021 at 10am at the registered premises of TUH, 438 St Pauls Terrace, Fortitude Valley, Brisbane.
 - Entry into the promotion is open to Australian residents only aged 18 years or older.
 - Total prize includes Prezzy gift cards equivalent in value to the amount of the winner's yearly TUH health insurance premium, based on their cover at 1 April 2021 and after any eligible rebates and discounts are applied.
