"Black Friday" Offer TERMS AND CONDITIONS

Introduction

- The promoter is Auto & General Services Pty Ltd ABN 61 003 617 909, AFSL 241 411 (trading as Budget Direct) of Level 13, Toowong Tower, 9 Sherwood Road, Toowong 4066, Telephone: (07) 3377 8801 (Promoter) on behalf of the insurer, Auto & General Insurance Company Ltd (ABN 42 111 586 353) (Insurer).
- 2. Any advice is general only and doesn't consider your needs. Before acting on it, consider if it and the product is right for you by reading the Product Disclosure Statement (PDS), Target Market Determination (TMD) and Financial Services Guide.
- Information on how to enter, mechanics of entry and prizes form part of these Terms and Conditions. Entry into the promotion is deemed acceptance of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions prevail.

- 5. The Promotion commences at 5.00PM on 25 November 2021 and will cease at 11.59PM 26 November 2021 (Promotion Period). All times are in Australia Eastern Standard Time. Customers are ineligible to participate after the Promotion Period.

- 6. In order to be eligible for the Gift Card, the customer must meet all of the following criteria (Eligible Participant):
 - a. Be an Australian resident aged 18 or over at time of entry;

- b. Purchase a new Budget Direct branded Pet, Comprehensive Car and/or Combined Home and Contents policy (Eligible Budget Direct Policy).
- c. Complete the sale of the Eligible Budget Direct Policy within the promotional period.
- d. Ensure the Eligible Policy remains active and valid for a period not less than 21 days from the purchase date of the policy (Cooling-Off Period).
- e. Employees of Auto & General are not eligible for the promotion.
- f. Customers renewing their policies with Budget Direct or cancelling and replacing a Budget Direct policy for the sole purpose of participating in the promotion are not eligible for this promotion.

Privacy

- 10. The Eligible Participant will receive instructions to their nominated email address on how to redeem their Gift Card within 30 calendar days of qualifying.
- 11. This Promotion is not available in conjunction with any other promotion or offer, and the Promoter reserves the right to disqualify any person from receiving the Gift Card if any of the following occurs:

- a. If it suspects fraudulent activity; or
- b. for a breach of these Terms and Conditions; or
- c. if it decides the person has not acted in good faith; or
- d. for any false or misleading conduct of any kind.
- 12. The Gift Card can only be used for online purchases where visa is accepted. The Gift Card is not reloadable, transferable or exchangeable and cannot be taken as cash. If a Gift Card or receipt of it incurs a tax liability, the relevant recipient of the Gift Card is liable for payment of such tax.
- 13. Terms and Conditions of the individual Gift Card will be printed on the reward itself and/or be made available on the card supplier's website. Check your Gift Card for usage instructions and expiry date. Your selected Gift Card is not refundable or redeemable for cash. Expired Gift Cards cannot be extended or replaced.
